In pursuance of the approval of the Principal on 19.07.2021, the results of +3 2<sup>nd</sup> Semester Examinations (Regular)-2020 of 2019 AB(Arts/Science/ Commerce) Honours, +3 4<sup>th</sup> Semester (Regular)-2020 of 2018 AB(Arts/Science/ Commerce) Honours, and PG(Arts) 2<sup>nd</sup> semester Examinations-2020(2019AB) are here by published provisionally.

**The date of Publication of results:** 19.07.2020

As the results are purely provisional, any discrepancy detected at any stage, the college may alter or cancel the results within a period of three months from the date of publication of the results.

Any omission or mistakes may be brought to the notice of the controller of examinations within 30 days from the date of publication of results with all details and supporting documents ,i.e. admit card, mark sheets issued etc.

The students can visit the college website [shailabalawomenscollege.ac.in](http://shailabalawomenscollege.ac.in) to get the results. Further, to get marksheet online, they have to click on "Results" and proceed as per instructions prompted on the screen

The results of above mentioned Examinations have been published adopting alternative evaluation method as mentioned below:

**ALTERNATIVE EVALUATION METHOD ADOPTED FOR UG:**

Intermediate Semesters of Under Graduate (Regular Examination) 2020 (4<sup>th</sup> Semester for 2018 Admission Batch & 2<sup>nd</sup> Semester for 2019 Admission Batch):

**(i) For Subjects without Practical**

- Internal marks secured as per the prescribed weightage (out of 20) have been awarded in respective papers.
- Average of End Semester marks obtained in all previous Semesters in all Papers of core Honours papers have been awarded against the Paper (S) of that subject category as per the prescribed weightage.



**(i) For Subjects with Practical**

- Internal marks secured as per the prescribed weightage (out of 15) have been awarded in respective papers.
- Average of End Semester (Theory) marks obtained in all previous semesters in all core Honours papers of have been awarded against the Papers of that subject categories as per the prescribed weightage.
- Average of Practical marks secured in all previous semesters (in respective Core/GE/DSE papers) have been awarded as per the prescribed weightage (out of 25)

**Elaborations:**

1. Average of the marks secured in End Semester of all Core Papers from Core-I to Core-VII have been posted as End Semester mark in Core- VIII,IX & X for 4<sup>th</sup> Semester Examination, 2020 (Admission Batch 2018).
2. Average of the marks secured in End Semester of all Core Papers from Core-I & Core-II have been posted as the End Semester mark in Core-III & Core-IV for 2<sup>nd</sup> Semester Examination, 2020 (Admission Batch).
3. In case of Practical, Marks for Core-VIII,IX & X (for 4<sup>th</sup> Sem.2020) or Core-III & Core-IV Practical (for 2<sup>nd</sup> Semester Exam,2020), the average of the marks secured in Practical papers in all previous Semesters (i.e. average of the practical marks of Core-I to Core-VII for 4<sup>th</sup> Semester ,and average of Practical marks of C-I &C-II for 2<sup>nd</sup> Semester) have been posted against all corresponding practical papers.
4. For Commerce (Hons) Students
  - (a) In Core-X which is a paper with Practical: marks been awarded by proportionate calculation from the average of all the Core Papers i.e. from C-I to C-VII.
5. GE I mark has been awarded in GE II, GE3 marks have been awarded for GE4, and SEC1 mark has been awarded in SEC2.
6. Similarly, AECC1 mark has been awarded for AECC2

**ALTERNATIVE EVALUATION METHOD ADOPTED FOR PG:**

Intermediate Semesters (SECOND SEMESTER) of Post Graduate Examination,2020  
(Admission Batch 2019)

- Internal marks secured as per the prescribed weightage (out of 20)
- Average of the marks secured in End-Semester of all the Hard Core Papers of PG 1<sup>st</sup> Semester, have been awarded against the End Semester papers of PG 2<sup>nd</sup> Semester irrespective of the subject category (HC/AE)

**For Practical Subjects:** For PG students with Practical Paper i.e. Marks secured in HC-IV have been posted against the End Semester mark of other Practical paper HC-VI (Practical).

In cases where average marks exceeded maximum marks allotted for a paper, in that case maximum mark has been awarded.
