


In the first session of the programme Prof. Atanukumar Pati discussed the various educational policies chronologically since 1854 till date. The major highlights of each policy were deliberated that included promotion of English language, vocational education, women education, grant-in-aid policies and establishment of universities, adoption of mother tongue etc. While discussing the development of education in post independent era, Prof. Pati elaborated on different commissions like, Radhakrishnan Commission, Kothari Commission etc before elaborating National Education Policy (NEP).

2020. The vision of this policy were highlighted and discussed. Some of them were 1. Making India a global super power, 2. High quality education for all, 3. Complete overhaul and reengineering higher education system consisting of large multidisciplinary HEIs, 4. Aim to increase GER by 50% by 2035, 5. Establishment of research foundation to fund peer reviewed research, 6. Expenditure on education @ 6% of GDP, 7. Need for creation of large pool of trained teachers etc. NEP 2020 recommends an educational system that is flexible, multidisciplinary, aligned to the need of 21st century with sustainable development goals.

In the second session Prof Susmit Prasad Pani focussed on "Implementation of NEP 2020". The key points of his deliberations were 1. Implementation of NEP to start by all universities & leading colleges by July 2023. 2. Developing own curriculum compatible with NEP, 3. Design of course credits, 4. Draft model regulations for UG programmes with multiple entry & exit options, 5. Registration under Academic Bank Credit (ABC) and transfer of credits, 6. ~~Introduction~~ Introduction of Ability Enhancement Course (AEC) for choosing modern Indian language, Skill Enhancement Courses (SEC) for choosing practical skills, analytical thinking & logical reasoning etc, 7. Introduction of multidisciplinary programmes which will include faculty offered broad discipline programmes where students can opt for courses outside their discipline, 8. Introduction of value added courses in different semesters, internship programmes and marks for attendance etc. Prof Pani Summed up his deliberations with objective of NEP 2020 which focusses on improvement by boosting the variable such as infrastructure, ambience, abilities etc.

Each sessions were ended with a rigorous discussions by the attendees. About 75 regular teachers had attended the programme and they were distributed with participant certificates. Feedbacks were also obtained by the IQAC.
