1. Approve the Regulation and syllabus of 2024.


2. Approve the name of Board of moderators for 1st and 2nd sem 2024-25.


3. Approve the name of Board of paper setter also for 1st and 2nd sem 2024-25 only.


4. Approve the list of Examiners for 1st and 2nd sem 2024-25.
