NOTICE NO. 890 DT. 10.08.2026

The Government vide letter No. 41491/HE, dated 01.08.2026 of the Higher Education, Government of Odisha, has extended the benefit of **fee waiver of readmission fees** under the Gyanodaya-Shikshya RU Samruddhi Scheme for the academic session 2026-27, to the students of 2nd year and 3rd year UG courses and 2nd year PG courses under SAMS. Thus, the **students of UG 2nd Year/3rd year, Arts/Science/Commerce and PG 2nd year, Arts and Science, are hereby informed to follow the steps as given below, to avail the fee waiver benefit:**

1. Use your existing **User ID and Password** (used during your Admission time) to log into the **SAMS portal**.

Then the portal shall automatically display the admitted institution name, course, subject, mode of programme, academic year and previous year of admission.

2. **Check carefully** whether all details of information displayed are correct.
3. **Put your attendance** of the previous academic session (75% attendance as- Yes/No)
4. Tick the **consent to the terms and conditions** of the scheme.
5. Then, **submit** the online readmission request.

The readmission request submitted by the students shall be reflected in the College e-Space, and will be verified (information furnished by the students) by the officer(s) concerned, if it is found correct, then only it will be approved and submitted. Thereafter, the Government will release the assistance and the readmission fee to the eligible institution.

Students must submit their readmission requests between 11.08.2026 and 20.08.2026 in the SAMS portal positively, otherwise, they will not be allowed to do so after the expiry of the stipulated period. Thereafter, the SAMS portal will also not be able to accept any readmission request.
